**Subject:** Making the approval process of the CAP Strategic Plans open and ambitious

Honourable Commissioners,

The design and approval of the future 27 CAP Strategic Plans are decisive moments to demonstrate commitments towards a fairer, greener, and rural-proofed CAP reform at national and regional levels.

The European Commission and the Member States can rely on the expertise, knowledge, and motivations of a wide range of actors to ensure that the quality and level of ambition of the future CAP plans are high.

Farmers, agro-ecologists, public authorities, civil society organisations, researchers and citizens can all become **active actors** if the approval procedure between the Commission and the Managing Authorities is **open and ambitious**.

In this context, we coalitions from nine Member States – working closely with a wide range of stakeholders and organisations, including farmers' ones, and directly involved in the preparation of the respective national CAP Strategic Plans – demand the European Commission and the Member States set up an approval procedure to:

- **Enable the access to all draft or partial draft CAP plans** exchanged between the Managing Authorities and the Commission until their final versions/approval.
- **Receive the latest notifications on the state-of-play of the plans** (e.g. submissions, assessments, feedbacks, revisions, pending approval/rejection), as well as the contact information to reach out the European Commission's officers and external assessment support for queries and observations on the CAP Strategic Plans.
- **Independently assess the draft CAP plans, as well the quality of the Commission's approval procedure** (e.g. coherence, transparency, rigor, ambition).

To achieve these specific objectives, the European Commission's Directorate-Generals AGRI, CLIMA, ENV and SANTE, in cooperation with the national ministries with shared competences on the Common Agricultural Policy, should implement the following six actions:

- 1. Demonstrate how they will operatively cooperate throughout the approval process**, for instance by presenting their timelines, sharing the best data and information on the drafted plans and creating common communication channels directly with the Member States.
- 2. Publish well in advance the tools to screen, assess, and approve the drafted CAP strategic plans** (criteria, grids, guidelines, data sources), and engage citizens in this participatory process through the future CAP networks.
- 3. The results of European Commission' assessments of the submitted plans should be published fully**, as should observation letters and recommendations given to modify and approve the draft CAP Strategic Plans. Particular attention should be given to the 'non-backsliding principle'; scientific justifications to accept certain 'practices under eco-schemes'; the quality of ex ante evaluations and strategic environmental assessments; rural proofing; and the substantial contribution towards fairer CAP plans (e.g. definitions of active farmers, capping, redistribution, maximum level for the value of payment entitlements, convergence, social conditionality).
- 4. A public communication channel should be created by the Commission and Member States** to allow civil society organisations, farmers, or researchers to send queries, prompt feedback, relevant data, or suggestions on the submitted materials.
- 5. Identify the areas where decisions made in the National CAP Strategic Plans are lacking data and information** in order to improve their future planning, performance monitoring and evaluation.
- 6. Collect and publish the final and full versions of the approved National CAP Strategic Plans in one single portal and in their national languages.**

An equal appraisal and rigorous approval of the CAP Strategic Plans should be implemented regardless of political power, timing of submissions, and delivery models across the 27 Member States.

To avoid the situation whereby granted flexibility to the Member States culminates in a race - to-the-bottom, we urge the Commission to set up this open procedure which promotes transparency, consistency, science, citizens engagement, and socio-ecological justice. We count on your actions.
